



FLEX REWARDS 2026

Terms & Conditions

Program Period: The 2026 Corteva Flex + Rewards Program begins on September 1, 2025 and ends on August 31, 2026.

Eligibility: The offer is open to growers who reside in Manitoba, Saskatchewan and Alberta and the Peace Region of British Columbia. As a condition of eligibility for any program payment offered by Corteva, the grower must provide authorization (a) for Corteva to communicate with grower to the extent required for the administration of the Corteva Flex + Rewards Program, and (b) for Corteva to access, collect, and use the grower's data as necessary to administer the Corteva Flex + Rewards Program, evaluate eligibility, and improve program operations. This consent shall remain valid until revoked by the grower. Growers who were authorized to receive program payments in the previous program period shall be deemed authorized for the subsequent program period, unless otherwise notified by Corteva or unless the grower withdraws authorization. A minimum rebate of \$100.00 must be earned before payment is made. No checks for less than \$100.00 will be issued without program management approval.

How to Qualify: A minimum purchase of \$25,000 of eligible Corteva products are required to qualify for the Corteva Flex + Program.

The program reward calculation is based on 2026 Suggested Retail Price (SRP).

Qualify for Start with Corteva Bonus:

To be eligible for the Start with Corteva Bonus, a minimum purchase of a combined 300 acres or more of either Corteva seed and/or cereal Seed Applied Technologies is required. Once qualified, a reward of 3% on all eligible products purchased will be applied. Corteva Seed Brands are qualifiers for the Start with Corteva Bonus but are not eligible to receive Corteva Flex + Rewards.

Qualify for Innovation Bonus:

To be eligible for the Innovation Bonus, a minimum purchase of a combined 300 acres or more of any products in the Innovation category is required. Once qualified, a reward of 3% on all eligible products purchased will be applied.

To be eligible for the Category Rewards, a minimum purchase of 3 categories is required. 300 acres of each category is required.

Qualify for Corteva Biologicals Bonus:

To be eligible for the Biologicals Bonus, a minimum of 300 acres of eligible Corteva Biological products must be booked and submitted by an eligible crop protection dealer by March 15, 2026. If this minimum is met, a reward of 8% on matching purchased acres is provided. Qualifying for any other portion of Corteva Flex+ Rewards, a reward of an additional 2% on eligible Corteva Biological Products will be provided. In the case of Fortified Stimulate Yield Enhancer, the reward is 13% for early booking (instead of 8%). Qualifying for any other portion of Corteva Flex+ Rewards, a reward of an additional 2% on Fortified Stimulate Yield Enhancer (15% total) will be provided.
